 - d If Sound and Vision decides to withdraw the GTAA, the Licensee will destroy their copies of the GTAA.
 - 4. **Acknowledgment:** All publications and presentations containing portions of the GTAA must carry the following acknowledgment: The Sound and Vision thesaurus is copyrighted. The Sound and Vision Thesaurus used in this work is provided solely for research purposes through OAEI 2008.
 - 5. License fee: No license fee shall be due to Sound and Vision pursuant to this License.

- 6. Sound and Vision monitoring right: Licensee shall provide Sound and Vision with reasonable access to the Project in order for Sound and Vision to monitor and evaluate the use of the GTAA
- 7. **Termination:** This License may be terminated by either party for any reason upon seven (7) days written notice to the other.
- 8. **General:** This License shall not be construed to create a partnership, agency, or joint venture relationship between the parties, or any relationship other than the relationship created specifically herein. Moreover, nothing herein authorizes Licensee to sell or distribute the GTAA to other distributors. This License shall have no force or effect until this License has been signed by Licensee with a copy returned to Sound and Vision.
